Dal momento che sia la Cannabis che l'alcool possono influenzare le funzioni cognitive, spesso è assunto che l'uso di Cannabis condizioni negativamente la performance di guida parimenti a quanto avviene per l'alcool: mentre il grado di disabilità correlato all'assunzione di alcool può essere stimato sulla base della concentrazione ematica misurata, non è stata invece del tutto accertata una chiara relazione tra le concentrazioni di cannabinoidi rilevate nel sangue o nella saliva e il corrispondente grado di disabilità. Compression reduces the file size, making it easier to share and download. Can I fill out forms in a PDF file?
